5. Memberships paid monthly will automatically renew at the end of your 12 month period unless the RSC receives an amendment form marked as Do Not Renew by the first of the month prior to your renewal date.
6. No refunds will be given if an error is found more than 90 days out.
7. **I understand that I am committing to one year to receive the benefit of basic land aerobics classes. This pass is non-transferrable.**

FACILITY MEMBERSHIP CRITERIA/GUIDELINES/RULES

- Proof of residency is required at the time of purchase or renewal to receive the resident discount.
- Parent or guardian must be present to register a member under 18 years of age.

Proving residency is simple and provides multiple options!

In order to receive a Resident Privilege Card (either new card or renewal card), an applicant must submit BOTH (Proof of Identification) and (Proof of Residence).

All you need to bring is:

Picture ID/Proof of Identification (16 years of age and older)

1. Valid Missouri Driver’s License
2. Valid Missouri Identification Card (available at Driver’s License Bureau)
3. Valid Military Identification Card



Plus ONE of the following:

Proof of Residence

1. An unpaid utility bill (gas/electric, water/sewer, trash, telephone or cable) with matching address.
2. Your current St. Charles County Property Tax notice with your name and address.
3. Your most recent personal income tax statement.
4. An up-to-date rental lease. A current rent receipt with your name and address on a printed form with name and telephone number of manager/owner.
5. A current Car Registration.
6. A current Voter Registration.
7. Personal check with a pre-printed name and address.

NOTES:

- a. Individuals under the age of 16 must have a parent/guardian with them at the time of issuance.
 - b. **If the picture ID does not include a current address**, you will be required to provide an additional second proof of current address along with the picture ID.
- Annual Pass Holders must comply with facility rules and regulations of the Parks and Recreation Department or the privilege of using the facility and its amenities may be revoked without a refund.
 - **Children ages 8 and under are not allowed to use the fitness area or track. Children age 9-15 may only utilize the track only when accompanied by a parent. Children between the ages of 12-15 may use the Fitness Area after successfully completing a Youth Fitness Orientation at an additional cost.**
 - Annual Pass Holders are expected to carry their “cards” on them at all times in order to receive the appropriate rates, services, or privileges. This is for the Pass Holder’s benefit. If a card is forgotten, the appropriate Non-Pass Holder fee will be charged for the services.
 - There is a \$5 fee for the replacement of a lost or stolen card.
 - All family members must be declared when a card is initially purchased.
 - A picture is required for each individual age 3 and older being issued a card.
 - Misuse of membership ID and/or privileges may result in cancellation or suspension of membership.

Definition of Family:

A Resident Family is defined as up to five people residing at the same address within the corporate limits of the City of O’Fallon. The cost of each additional individual over the limit of five is \$25 per year.

A Non-Resident Family is defined as up to four people residing at the same address outside of the corporate limits of the City of O’Fallon. The cost of each additional individual over the limit of four is \$50 per year.

Initials Includes basic land aerobics classes without registering. Sign in at the front desk. Admission is on a first come first served basis. Specialty aerobics classes are not included. Please refer to the brochure for available classes. Members 12 – 15 years of age must be accompanied by a parent or legal guardian to attend all aerobic classes.

Initials All memberships have the option of an annual payment or a monthly payment.

Initials Individuals choosing to purchase a pass using monthly installments will be subject to a \$50.00 re-activation fee if a pass is cancelled and a request for a new membership occur within twelve months of the membership being issued.

Initials This contract may not be cancelled by the member unless one of the following occurs
 The member moves more than 25 miles away from our facility and if so must provide 2 proofs of address change. It is then up to the discretion of our staff to determine the distance from our location to the new address.
 The member is deemed unable to use any part of our facility by a physician and must provide a signed letter from that physician.
 The member passes away and in such a case the membership is null and void.
 The one-year contract has been completed.
